### Overview

As the Arizona travel, tourism, and hospitality industries recover from the pandemic, the Legacy Golf Course Revitalization Program will provide assistance to older golf courses to implement infrastructure updates that modernize the courses and make them more sustainable. Golf driven tourism was tied to 2.4 million visitors and brought an estimated \$2.2 billion to the Arizona economy in 2019, supporting 24,100 jobs.
