<sup>1</sup>Glen Canyon NRA and Lake Mead NRA both encompass two states. Only the Arizona portion of visitors are represented here. Revised formulas are being used by both Glen Canyon NRA and Lake Mead NRA for 2018 and 2019 relative to prior years. At Glen Canyon NRA, Horseshoe Bend counts are now being reported separately and are included above. Canyon de Chelly NM also reported using a revised counting protocol in 2018 and 2019.

December Notes: National Park Service operations in 2018 were influenced by the Federal Government shutdown on 12/22/18 that continued into January 2019. Grand Canyon NP remained open however with limited services during that shutdown.

Specific notes for December 2019 follow: At Coronado NM construction in the park may have effected traffic counts. The Visitor Center at Hubbell Trading Post NHS was closed on Sundays and Mondays due to staffing limits. Navajo NM reported issues with traffic counters and resulting loss of data. Organ Pipe Cactus NM reported issues with non-functioning traffic counters and resulting estimated data. Pipe Spring NM reported weather related declines.
