Revised formulas are being used by both Glen Canyon NRA and Lake Mead NRA for 2018 and 2019 relative to prior years. At Glen Canyon NRA, Horseshoe Bend counts are now being reported separately and are included above. Canyon de Chelly NM also reported using a revised counting protocol in 2018 and 2019. November Notes: November 11th was an NPS fee free day (Veterans Day). At Coronado NM construction in the park may have affected traffic counts. Grand Canyon NP reported snow related issues including power outages during the Thanksgiving Holiday. Pipe Spring NM also reported weather related declines. The Visitor Center at Hubbell Trading Post NHS was closed on Sundays and Mondays due to staffing limits. Navajo NM reported issues with traffic counters and resulting loss of data. Organ Pipe Cactus NM reported issues with non-functioning traffic counters and resulting estimated data.
