April Notes: April 16th was a NPS fee free day (Beginning of National Park Week). The Lake Mead NRA visitor counts representing the AZ portion for 2021 and 2022 are estimated. In 2022, Glen Canyon NRA reported that most launch ramps were closed due to the low lake level. Hubbell Trading Post NHS offered formal programming for National Park Week. Grand Canyon NP received detoured traffic at Desert View (east entrance) for six days due to a wildfire caused highway closure north of Flagstaff. Tonto NM was closed for one day due to a power outage. Sunset Crater Volcano NM counts were incomplete due to wildland fire. Wupatki NM was closed for 10 days due to the Tunnel Fire. Coronado NM, Petrified Forest NP and Saguaro NP reported issues with traffic counters.
