March Notes: The Lake Mead NRA visitor counts representing the AZ portion for 2021 and 2022 are estimated. In 2022, Canyon de Chelly NM began offering more public programming. Glen Canyon NRA reported that most launch ramps were closed due to the low lake level. Hubbell Trading Post NHS offered limited services but also hosted several group tours. Canyon de Chelly NM, Coronado NM, Grand Canyon NP, Montezuma Castle NM, Navajo NM, Saguaro NP and Tuzigoot NM all reported issues with traffic counters.
