August Notes: August 4th (anniversary of the Great American Outdoors Act) was a fee free day. The Lake Mead NRA visitor counts representing the AZ portion are estimated. Fort Bowie NHS visitor center was only open Sunday and Monday. At Grand Canyon NP, wildland fire on the North Rim resulted in numerous closures including inner canyon trails. The Petrified Forest NP visitor center was closed for construction requiring the use of estimates. Traffic counter issues and resulting estimates reported at Lake Mead NRA, Montezuma Castle NM, Saguaro NP and Sunset Crater Volcano NM.
