Glen Canyon NRA does not include counts for Lees Ferry and Horseshoe Bend sites in November 2024. Lake Mead NRA, Saguaro NP, and Sunset Crater Volcano NM reported traffic counter issues. Sunset Crater NM was closed for 10 days. Navajo NM, Tonto NM and Wupatki NM Visitor Centers were closed on Thanksgiving day. Fort Bowie Visitor Center was closed on Tuesdays. Hubbell Trading Post NM and Navajo NM hosted special events for Native American Indian Heritage Month.
