November Notes: November 11th was a NPS fee free day (Veterans Day). The Lake Mead NRA visitor counts representing the AZ portion are estimated. The federal government shutdown continued to impact operations at numerous parks into November with some resuming operations on November 13th. Collection of visitor data was altered or unavailable in numerous parks. Lake Mead NRA and Montezuma Castle NM reported continuing traffic counter issues. At Grand Canyon NP corridor campgrounds and Phantom Ranch reopened and the North Rim offered day-use only access until November 14th when it closed for the season. The Petrified Forest NP visitor center was closed for construction requiring the use of estimates.
